SUMMARY JUDGMENT MOTIONS HAVE DIFFERENT DEADLINES

Rule 4:46-1 generally requires moving papers at least 28 days before the return date and opposition at least 10 days before. Reply papers are due no later than four days before the return date, with the short-period computation addressed by Rule 1:3-1. Confirm the current Rules and any case-specific order before filing.
